Pursuant to Mont. Code Ann. § 33-2-118, the Office of the Montana State Auditor, Commissioner of Securities and Insurance (CSI), revokes Lumbermen's Underwriting Alliance (Lumbermen's) certificate of authority for the following reasons:

1. The State Auditor is the Commissioner of Securities and Insurance (Commissioner). § 2-15-1903.
2. The CSI is under the control and supervision of the Commissioner. §§ 2-15-1902 and 33-1-301.
3. The Commissioner shall administer the CSI to protect insurance consumers. § 33-1-311(3).
4. The Commissioner and the CSI have jurisdiction over this matter. § 33-1-311.
5. The Commissioner shall suspend or revoke an insurer's certificate of authority if the insurer's authority to transact insurance is suspended or revoked by its state of domicile. § 33-2-118(c).

6. Lumbermen's is a Missouri domiciled property and casualty insurer, Certificate of Authority # 4851.

7. Lumbermen's was placed in liquidation by the Missouri Department of Insurance.


ORDER

THEREFORE, IT IS HEREBY ORDERED that based on the foregoing,
LUMBERMEN'S UNDERWRITING ALLIANCE'S Certificate of Authority #4851 is
REVOKED.

IT IS FURTHER ORDERED that Lumbermen's may not issue new policies or renew current policies. It may service existing policies.

IT IS FURTHER ORDERED that Lumbermen's is not relieved of its duty to pay Montana premium tax. § 33-2-102.
