Michael Winsor, Special Deputy Gallatin County Attorney, attorney for the State of Montana, having first obtained leave of the Court, files this information accusing the above named Defendant, MARK ANTHONY BOONE, of having committed the following offenses:

COUNT ONE

That on or about the 24th day of January, 2005, in Gallatin County, Montana, the above named Defendant committed the offenses of INSURANCE FRAUD/THEFT, A FELONY, in violation of Section 33-1-1202, and 45-6-301(6)(a), MCA.

The facts constituting this offense are as follows:

That at the times and place above mentioned, the Defendant purposely or knowingly, for the purpose of obtaining money and/or benefits, presented or caused to be presented to Gallatin Insurance Agency in Belgrade Montana written and/or oral statements containing false, incomplete or misleading information concerning facts and/or things material to, as part of, or in

support of a claim for payment or other benefit pursuant to an insurance policy, to wit: claims for approximately \$1,745.00.

Penalty - a fine not to exceed \$50,000 and/or imprisonment in the state prison for any term not to exceed 10 years.

COUNT TWO

That on or about the 11th day of November, 2005, in Gallatin County, Montana, the above named Defendant committed the offenses of INSURANCE FRAUD/THEFT, A FELONY, in violation of Section 33-1-1202, and 45-6-301(6)(a), MCA.

That at the times and place above mentioned, the Defendant, purposely or knowingly committed insurance fraud by presenting to Gallatin Insurance Agency written and/or oral statements containing false, incomplete or misleading information concerning facts and/or things material to, as part of, or in support of a claim for payment or other benefit pursuant to an insurance policy, to wit: claims for approximately \$1,550.00.

Penalty – a fine in an amount not to exceed \$50,000 or imprisonment in the state prison for a term not to exceed 10 years, or both.

COUNT THREE

That on or about the 15th day of December, 2005, in Gallatin County, Montana, the above named Defendant committed the offenses of INSURANCE FRAUD/THEFT, A FELONY, in violation of Section 33-1-1202, and 45-6-301(6)(a), MCA.

That at the times and place above mentioned, the Defendant, purposely or knowingly committed insurance fraud by presenting to Gallatin Insurance Agency written and/or oral statements containing false, incomplete or misleading information concerning facts and/or things

material to, as part of, or in support of a claim for payment or other benefit pursuant to an insurance policy, to wit: claims for approximately \$4,419.00.

Penalty – a fine in an amount not to exceed \$50,000 or imprisonment in the state prison for a term not to exceed 10 years, or both.

COUNT FOUR

That on or about the 16th day of January, 2006, in Gallatin County, Montana, the above named Defendant committed the offenses of INSURANCE FRAUD/THEFT, A FELONY, in violation of Section 33-1-1202, and 45-6-301(6)(a), MCA.

That at the times and place above mentioned, the Defendant, purposely or knowingly committed insurance fraud by presenting to Gallatin Insurance Agency written and/or oral statements containing false, incomplete or misleading information concerning facts and/or things material to, as part of, or in support of a claim for payment or other benefit pursuant to an insurance policy, to wit: claims for approximately \$4,169.00.

Penalty – a fine in an amount not to exceed \$50,000 or imprisonment in the state prison for a term not to exceed 10 years, or both.

COUNT FIVE

That on or about the 1st day of February, 2006, in Gallatin County, Montana, the above named Defendant committed the offenses of INSURANCE FRAUD/THEFT, A FELONY, in violation of Section 33-1-1202, and 45-6-301(6)(a), MCA.

That at the times and place above mentioned, the Defendant, purposely or knowingly committed insurance fraud by presenting to Gallatin Insurance Agency written and/or oral statements containing false, incomplete or misleading information concerning facts and/or things

material to, as part of, or in support of a claim for payment or other benefit pursuant to an insurance policy, to wit: claims for approximately \$3,916.20.

Penalty – a fine in an amount not to exceed \$50,000 or imprisonment in the state prison for a term not to exceed 10 years, or both.


COUNT SIX

That on or about the 14th day of February, 2006, in Gallatin County, Montana, the above named Defendant committed the offenses of INSURANCE FRAUD/THEFT, A FELONY, in violation of Section 33-1-1202, and 45-6-301(6)(a), MCA.

That at the times and place above mentioned, the Defendant, purposely or knowingly committed insurance fraud by presenting to Gallatin Insurance Agency written and/or oral statements containing false, incomplete or misleading information concerning facts and/or things material to, as part of, or in support of a claim for payment or other benefit pursuant to an insurance policy, to wit: claims for approximately \$6,488.95.

Penalty – a fine in an amount not to exceed \$50,000 or imprisonment in the state prison for a term not to exceed 10 years, or both.
