On June 23, 2016, the Defendant appeared before this Court with counsel, Nathan J. Hoines, and entered a plea of guilty to **Count I: Theft, a Misdemeanor; and Count II: Deceptive Practices, a Misdemeanor**. The State appeared through Mike Winsor, Special Assistant Attorney General and Special Deputy Hill County Attorney.

The parties agreed to proceed to sentencing. Based on the record:

IT IS HEREBY ORDERED, ADJUDGED and DECREED, as follows:

1. Defendant is guilty of **Count I: Theft, a Misdemeanor**, violation of Mont. Code Ann. § 45-6-301.

A. Defendant is sentenced to six months in the county jail, all suspended, subject to the following:

i. Defendant shall pay a \$15.00 misdemeanor surcharge by cashier's check or money order to the **Hill County Clerk of District Court, 315 Fourth Street, Havre, MT 59501**.

ii. Defendant shall pay a \$50.00 victim/witness surcharge by cashier's check or money order to the **Hill County Clerk of District Court, 315 Fourth Street, Havre, MT 59501**.

iii. Defendant shall pay a \$10.00 court information technology fee by cashier's check or money order to the **Hill County Clerk of District Court, 315 Fourth Street, Havre, MT 59501.**

iv. Defendant shall remain law abiding.

v. All fees and surcharges shall be paid within three months of sentencing.

2. Defendant is guilty of **Count II: Deceptive Practices, a Misdemeanor**, in violation of Mont. Code Ann. § 45-6-317.

A. Defendant is sentenced to six months in the county jail, all suspended, subject to the following:

i. Defendant shall pay a \$15.00 misdemeanor surcharge by cashier's check or money order to the **Hill County Clerk of District Court, 315 Fourth Street, Havre, MT 59501.**

ii. Defendant shall pay a \$50.00 victim/witness surcharge by cashier's check or money order to the **Hill County Clerk of District Court, 315 Fourth Street, Havre, MT 59501.**

iii. Defendant shall pay a \$10.00 court information technology fee by cashier's check or money order to the **Hill County Clerk of District Court, 315 Fourth Street, Havre, MT 59501.**

iv. Defendant shall remain law abiding.

v. All fees and surcharges shall be paid within three months of sentencing.

vi. Count II shall run consecutively to Count I.

JUDGE OF DISTRICT COURT

If a written judgment and an oral pronouncement of sentence or other disposition conflict, the Defendant or the prosecutor in the county in which the sentence was imposed may, within 120 days after filing of the written judgment, request that the court modify the

written judgment to conform to the oral pronouncement. The court shall modify the written judgment to conform to the oral pronouncement at a hearing, and the Defendant must be present at the hearing unless the defendant waives the right to be present or elects to proceed pursuant to Mont. Code Ann. § 46-18-115. The Defendant and the prosecutor waive the right to request modification of the written judgment if a request for modification of the written judgment is not filed within 120 days after the filing of the written judgment in the sentencing order.
