This notice is to inform you of the time, place, and nature
of the hearing. Pursuant to a September 15, 2016, Order Setting
Scheduling Conference, the undersigned Hearing Examiner held a
telephonic scheduling conference on Wednesday, September 21,
2016, at 10:00 a.m. Mountain Daylight Time (MDT). Respondent did
not appear, although Ms. Harris informed the undersigned that in
a recent telephone conference with Respondent she personally had
reminded him of the scheduling conference. At the scheduling
conference this matter was scheduled for a one (1) day hearing to

1 be held Wednesday, February 1, 2017, at 9:00 a.m. Mountain
2 Standard Time (MST), at the following location: State Auditor's
3 Office, 840 Helena Avenue, Helena, Montana. The following
4 prehearing schedule also was established: The Commissioner of
5 Securities & Insurance (CSI) shall arrange a telephonic
6 prehearing conference of all parties and the undersigned to be
7 held on Thursday, January 26, 2017, at 9:00 a.m. (MST). All
8 prehearing motions are to be filed with the undersigned Hearing
9 Examiner not later than Friday, January 13, 2017, by 5:00 p.m.
10 (MST). The deadline for any response brief is fourteen (14) days
11 from the date of a motion, and for any reply brief is seven (7)
12 days from the date of the response brief. All exhibits and a
13 list of witnesses are to be exchanged and filed with the under-
14 signed Hearing Examiner not later than Friday, November 18, 2016,
15 by 5:00 p.m. (MST). All Rule 26(b)(4) (M. R. Civ. P.) expert
16 witness disclosures and expert witness reports are also to be
17 exchanged and filed with the undersigned Hearing Examiner not
18 later than Friday, November 18, 2016, by 5:00 p.m. (MST).
19 Discovery shall close Friday, December 30, 2016.

20 The nature of the hearing is as follows: The hearing shall
21 be confidential and not open to the public. The CSI shall allow
22 any party to the hearing to appear in person and by counsel, to
23 be present during the giving of all evidence, to have reasonable
24 opportunity to inspect all documentary evidence and to examine
25 witnesses, to present evidence in support of his interest, and to
26

1 have subpoenas issued by the CSI to compel attendance of
2 witnesses and production of evidence on his behalf. A record of
3 the proceedings will be made.


