Executive Summary

Overview

The Agenda Item to be considered by the Committee is the final rulemaking adoption of the NCCI classification item filing and amendments to the Administrative Rules of Montana, accepted and approved by the Committee, as proposed by NCCI, at the March 10, 2021 meeting. Upon the Committee's completion of rulemaking and publication of an amendment and adoption notice, adopting the final form of NCCI's classification item filing, NCCI will then submit the classification item filing to CSI for approval.
