This Consent Agreement (‘Agreement’) is entered into by the Office of the
Montana State Auditor, Commissioner of Securities and Insurance (“‘Csr.”), acting
pursuant to the authority of the Montana Insurance Code, Mont Code Ann. § 33-1-
1001 et seq (“code”). Liberty Mutual Insurance Limited, LLC [REDACTED].
The CSI and the Respondents will be referred to herein as the “Parties.” The final
order (“order”) is issued by the authority of the Commissioner of Securities and
Insurance. Montana State Auditor (“‘Commissioner’”) on the claim of your

Monetary prize which you are the sole winner to claim the cash prize as directed and instructed by the attorney in charge: “**Benjamin A. Vines**” (“Attorney”) of the rental property which you will be renting as a legal occupant of this rental property which the address is stated to be ([REDACTED], Bozeman, MT 59715) and the Landlord’s name which is: “[REDACTED]” (“Landlord”)

STIPULATIONS AND CONSENTS

1. Respondent stipulate and consent to the following:

- A. Respondent admit to enter in Agreement solely on the acceptance of the claim and will follow due procedure as binded by law on the insurance policy on the cash prize claim which was won by you.
- B. Respondent Agree that **\$7,000.00 USD** shall be paid to have the claim for the cash prize established and confirmed as a fund which is meant to activate the benefit in the Montana Insurance Policy. The claim and validation process shall be set by the CSI and the attorney in charge before you could fully move into the house.
- C. The CSI and Liberty Mutual Insurance Limited solely responsible for determining who is eligible for a payment from the fund and the amount to be paid as well, which you have no responsibility or liability of determination of who might be eligible for payment which the payment shall be made by check payable to:

- E. This is the entire agreement between parties and no other promises or agreement, have been made by CSI or by any member, office or agent, or representative of the CSI to induce respondent to enter into the Agreement
- F. The Agreement shall be incorporated into and made a part of the attached Final Order issued by the Commissioner at the office desk himself
- G. This Agreement shall be effective upon signing of the Final Order and this is also a public record under Montana law as such it valid and recorded for you as a legal renter in the State of Montana and we can assure you the validity of the Insurance Promo claims
